

# MARYLAND ASSOCIATION OF AGRICULTURAL FAIRS & SHOW, INC. FAIR PERSON OF THE YEAR

In recognition of devoted and invaluable service to the Maryland Association of Agriculture Fairs and Shows (MAAFS) and one of its member fairs, an annual award will be presented to an individual who exemplified and distinguished themselves by their commitment. The presentation of the award will be made to the recipient at the banquet during the annual convention. The award will consist of a plaque with the recipient's name inscribed thereon. The recipient's name will be added to the MAAFS Fair Person of The Year.

#### **ELIGIBILITY**

The conditions of eligibility are as follows:

- A Minimum of 10 years' service with a MAAFS member fair.
- The nominee must be living.
- The nominee shall have served as a Director, Officer, Volunteer, Staff Member, Friend of a Fair, or Manager of a MAAFS member fair.
- The nominee shall have been supportive in the affairs of MAAFS.
- The nominee must have shown consistent and significant service to MAAFS and one of its member fairs.
- The nominee must be nominated by a minimum of three MAAFS member fair representatives or two member fair representatives and one MAAFS associate member.

### **NOMINATIONS**

The procedure to be followed by the Awards Committee in the selection of a candidate shall be as follows:

- Each year, the Awards Committee shall announce at the annual meeting that nominations are now being accepted for next year's fair person of the year. A nomination form will be mailed to each member fair and be available on the MAAFS website.
- Nominations for the award must be returned with a record of the nominees achievements in
  the fair industry in sufficient detail so that the Award's Committee can pass judgment on the
  candidate's worthiness to receive the award. This record of achievement is included in the
  Fair Person of the Year Nomination form and is to be prepared by a representative of a
  MAAFS member fair with two additional member fairs or one additional fair and one additional
  associate member named as references.
- Each year, the recipients from the three previous years will serve as the selection committee with the prior year's recipient serving as chair of the selection committee. All nominations will be forwarded to and results tabulated by the chair of the Fair Person of the Year Committee.
- All questions coming before the Awards Committee shall be decided by a majority vote of the Committee. The Awards Committee shall have the responsibility power to decide any questions not specifically covered by these rules. The decisions of the committee are final.
